As per the G.O cited, District Mission Team(DMT) under the chairmanship of Superintendent of police of the district will be responsible for the implementation and review of the CCTNS project in the district. The DMT meeting should be conducted once in a month and proceedings drawn.


2. Though, the committee(DMT) has been formed in the districts/cities, it is found to be inactive.

3. Now, Crime and Criminal Tracking Network and Systems(CCTNS) has been implemented in all the districts/commissionerates. Go-Live status has been achieved on 30.09.2013 and live data flow from the police stations to the State Data Centre(SDC) is happening. The citizen portal has been enabled and online complaints are being sent to police stations and higher offices by the citizens.

4. At this juncture, a revised draft DMT proceeding format incorporating the salient points to be reviewed is enclosed for guidance.

5. Hence, Superintendents of Police, Commissioners of Police or Deputy Commissioners of Police designated by COPs for District Mission Team are instructed to conduct regular CCTNS - District Mission Team meetings every month and send the proceedings to the undersigned.
