Sub : CCTNS – Usefulness of vehicle search facility - Reg


As part of CCTNS project, the task of digitizing 10 years (2002-2011) historical case files besides, case files of 2012, 2013 has been completed by September, 2013. The live data entry for the current year 2014 is also happening. As a result, 38 lakhs records pertaining to Crime, Criminal, Stolen/Recovered vehicles, Missing Persons and Un-identified dead bodies have been stored in the State Data Centre.

2. All the police stations have been connected to the State Data Centre(SDC) through dedicated network which enables data flow from the police stations and also access to database in the SDC by police stations and higher offices. Facility to know the status of vehicles stolen/recovered/involved in crimes has been provided for the use of public and police through Citizen/Police portal.

3. While few districts, particularly those in South Zone have made good use of this facility (Vehicle Search), other districts elsewhere have used this only sparingly. In Madurai district the “Vehicle Search” facility in the CIPRUS application was used to verify vehicles seized u/s 102 CrPC and kept in few police stations viz., Avaniyapuram PS, Thirunagar PS, Thirumangalam Town PS, Karuppayurani PS, Nahamalai Pudukkottai PS. In a single day, 14 cases of stolen vehicles were detected by matching with the data of other stations in the district and also other districts like Madurai City, Pudukkottai and Sivagangai.

4. It is interesting to note that a vehicle concerned in 2004 case of Pudukkottai district was also traced. Needless to say that 28 cases of these 4 districts/city have been resolved.

5. Therefore, it is requested that all SPs/COPs may instruct the SHOs to make use of the facility available in CCTNS project effectively. If further training is required, the concerned SCRБ detachment Sub Inspector of Police may be approached. The action taken report may be sent to the undersigned for information and review.
