CIRCU LAR MEMORANDUM

Sub: CCTNS – District Training Centres (DTC) created for CCTNS project – Computers and other accessories – Supplied to DTCs – Not to shift to Police Station – Instruction issued.

State Crime Record Bureau has been designated as the Nodal Agency to implement Crime and Criminal Tracking and Network System (CCTNS) project. As part of Capacity Building initiative, Training Centres (DTC/CTC) were set up in all district head quarters.

2. Besides, in accordance with Chief Office memo second cited, SCRB detachments consisting of one Sub-Inspector of Police and two Police Constables have also been created at all district head quarters and commissionerates in order to assist the Nodal Officer to ensure complete and accurate data entry and to oversee the creation of connectivity and roll out of CCTNS system in the district / commissionerate.

3. Of late, it has come to notice that some computers and accessories were shifted from CCTNS training centres for other work in the districts and police personnel of SCRB detachment exclusively trained for CCTNS were also transferred to their police stations without the concurrence of SCRB.

4. M/s.NIIT Technologies Ltd., has been selected as System Integrator (SI) for implementation which includes site preparation, supply of hardware, installation of software, capacity building, data digitization, providing connectivity in co-ordination with BSNL across the state.

5. The implementation of the project is under way and the shifting of infrastructure and computer and other accessories from DTC for other work and transfer of police personnel from SCRB detachment would severely affect the progress of CCTNS project.

6. Therefore, all unit head are hereby strictly instructed not to divert any infrastructure supplied exclusively for CCTNS for other purpose. The strength of SCRB detachment also should not be shifted for other work or to their parent police station without the concurrence of Additional Director General of Police, State Crime Record Bureau. All unit heads are requested to extend their co-ordination for successful implementation of the project across the state.
