To deal with extremist militants religious fundamentalist using Anthrax, weapons of mass destruction etc.b. Providing men power to cities / Districts for controlling Law and Order Problems, clashes, as per the orders of superior viz. Director General of Police, Tamilnadu, Additional Director General of Police, Armed Police, Inspector General of Police , Armed Police and Deputy Inspector General of Police, Chennai – 10.c. Providing VVIP, VIP Escort, bandobust duties as per the orders of superiors.d. Strengthening skills of Police personnel of TSP Special Force by providing training to tackle the Law and Order problems, to deal with extremists militants, religious fundamentalist using anthrax (small Arm Course, Counter Terrorism Course and Foot drill cadre course etc.)e. To identity and encourage the skills of Police Personnel in sports and in various Specialties and given adequate training and selected for Armed Police team.
